IX. OLD BUSINESS

A. Discussion of President McKinley Statue and Jacoby's Storehouse Historic Designation Plaque.

The statue of President William McKinley and its base were a gift donated to the City of Arcata by George Zehndner on July 4, 1906. The bronze casting was the first major work of art done by noted Armenian immigrant sculptor Haig Patigian. The statue has been the subject of much discussion and debate spanning over several decades and was last formally discussed at a Council meeting in October of 2005.

Recent requests for removal of the statue and a rewording of a bronze plaque

identifying the Jacoby's Storehouse as a historic structure resulted in a study session that was held on December 4, 2017, at the D Street Neighborhood Center. The meeting was attended by approximately 80 people of which 43 individuals spoke during the public comment period.

RECOMMENDATION:

It is recommended that the Council review options, hear public testimony and provide direction to staff with regard to the Plaza President McKinley statue and plaque designating the Jacoby's Storehouse as a historic structure.
